

PETITION FOR INCORPORATION OF OGDEN VALLEY

To the Honorable Lieutenant Governor: We, the undersigned registered voters (and/or property owners) within the area described in this petition, respectfully petition the lieutenant governor to direct the county legislative body to submit to the registered voters residing within the area described in this petition, at the next regular general election (or next election allowed by law), the question of whether the area should incorporate as a municipality. Each of the undersigned affirms that each has personally signed this incorporation petition and is a registered voter who resides within the described area, and/or a property owner, and that the current residence address of each is correctly written after the signer's name. The area proposed to be incorporated as a municipality named "Ogden Valley" is depicted on the back of this page.

Notice to Petition Signers: A signature on this petition, unless the signer files a written withdrawal pursuant to Utah law, will be used for this petition and any subsequent petition. The signers of this petition appoint the sponsors, if the incorporation measure passes, to represent the signers in drawing district boundaries for the election of council members. Sponsors are also responsible for selecting the number of commission or council members that the new city will have; and drawing district boundaries of the election of council members by district if the voters decide to elect council members by district, and in fulfilling other responsibilities set by Utah law. By signing this petition, you acknowledge that, on the back of this page, you have been provided with an accurate plat or map of the area proposed to be incorporated, prepared by a licensed surveyor, showing the boundaries of the proposed municipality, as well as a link to that map and detailed written boundary description. 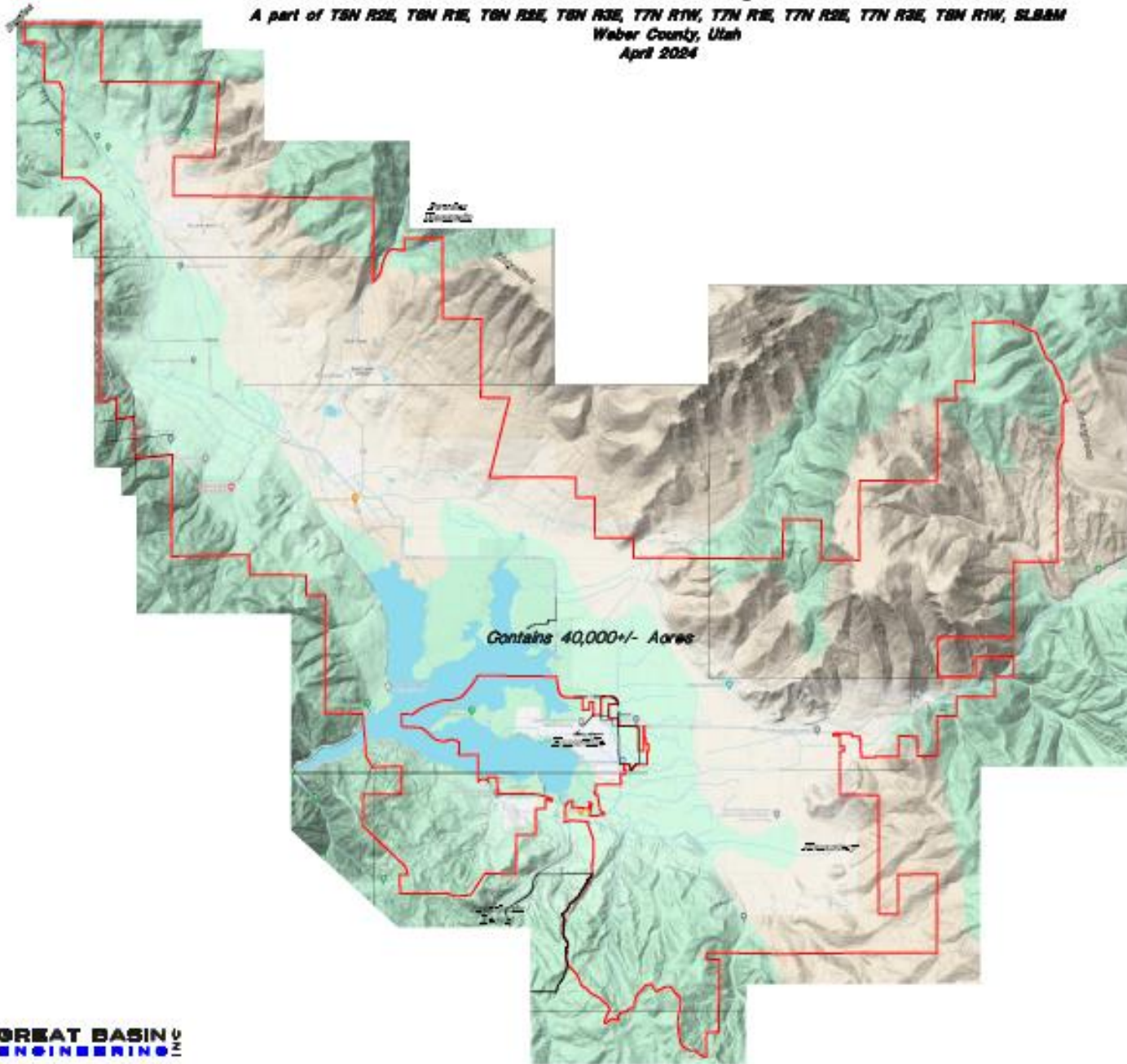
